7.10 pm		Mrs. Pelone provided a presentation providing an overview of student supports and services. The presentation is posted in the Team Drive in the 10/4/18 Meeting folder. Committee members had questions about school counselor ratios, and why the county has denied our application for an additional school based counselor funded by Bucks County Family Services for Richland Elementary. Other questions were about how we can spread the word and "market" that SAP and similar services are available other than the website and handbooks? This might be an area we could work on. Members also had questions about our PBIS programs, especially as implemented at the middle and high school levels. QCSD has completed all requirements of Act 44 that are required so far. Upcoming deadlines are submission of the grant application for Act 44 funds, completion of the school security survey (available on 10/31 and due by 11/30/18) and implementation of the Safe2Say tip line program in January 2019. Nancianne explained the grant application process and how the survey report will affect adjustments to the grant.
