## RIGHT TO KNOW INFORMATION

On January 8, 2002, President Bush signed into law the "No Child Left Behind Act" (NCLB). NCLB is designed to improve student achievement by increasing federal involvement in public education both at the state and local level. NCLB also requires special notification to parents when their child's school receives Title I funding. Your child's school received Title I funding this year.

Under NCLB, parents have the right to know the professional qualifications of their children's teacher(s). You have the right to ask the following questions:

## Title I

Title I is a federally funded program designed to improve educational opportunities by providing aid to elementary and secondary education. The intent of Title I is to expand learning opportunities while supplementing basic skills instruction in reading and math. This program serves students who have need. The goals of the Title I program are to:

- Individualize reading/language arts and math instruction according to student needs
- Increase reading/language arts and math achievement
- Increase student self-esteem
- Involve children with parent(s) in reading/language arts and math activities at school and at home
